ORDER:

In the Government Order first and second read above, the Government have issued orders for the implementation of the Integrated Financial and Human Resource Management System (IF&HRMS) Project, which envisages integration of both Financial and Human Resource Management. As the System contemplates end to end solution for all financial activities, various rules, procedure for drawing payments from Treasuries are being inbuilt in the system. The objective of this Project is to remove various systemic deficiencies in the manual legacy system of operation and optimizing efficiency through comprehensive business process re-engineering.

2) Accordingly, the Commissionerate of Treasuries and Accounts has proposed certain amendments to instruction 1 (b) under Treasury Rule 23 and the Government accepts the amendments proposed by the Commissionerate of Treasuries and Accounts.

NOTIFICATION

In exercise of the powers conferred by Article 283 (2) of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to instructions 1 (b) under Treasury Rule 23 in Volume-I of the Tamil Nadu Treasury Code and Note under Rule 5 in Appendix 17, in Volume-II of the Tamil Nadu Treasury Code.

The amendments hereby made shall be deemed to have come into force on the 10th January, 2019.

AMENDMENT

In the said Tamil Nadu Treasury Code, Volume-I, the instructions 1 (b) under Treasury Rule 23 the following shall be added:-

“Once the Government servant is transferred and his joining entries are updated in e-Service Register in the new station, old station Drawing and Disbursing Officer cannot view his pay Roll data and all the Data of transferred Government servant can be viewed by the new station Drawing and Disbursing Officer only. Hence, the present system of sending last pay certificate by the old station Drawing and Disbursing Officer to new station Drawing and Disbursing Officer shall be discontinued. However, in the case of Government Servants deputed to Foreign Service viz., Tamil Nadu State Government undertakings, Co-operative Institutions, Universities, other Autonomous Bodies, Government of India and other Governments the present system of sending Last Pay Certificate shall continue as they are not users of Integrated Financial and Human Resource Management System (IF&HRMS) Portal”.

In the Note under Rule 5 in Appendix 17, in Volume-II of the Tamil Nadu Treasury Code, the following Note shall be added:-

“Once the Government servant is transferred and his joining entries are updated in e-Service Register in the new station, old station Drawing and Disbursing Officer cannot view his pay Roll data and all the Data of transferred Government servant can be viewed by the new station Drawing and Disbursing Officer only. Hence, the present system of sending last pay certificate by the old station Drawing and Disbursing Officer to new station Drawing and Disbursing Officer shall be discontinued. However, in the case of Government Servants deputed to Foreign Service viz., Tamil Nadu State Government undertakings, Co-operative Institutions, Universities, other Autonomous Bodies, Government of India and other Governments, the present system of sending Last Pay Certificate shall continue as they are not users of Integrated Financial and Human Resource Management System (IF&HRMS) Portal”.
