In this connection, all the Executive Engineers are instructed to place supply order for procurement of all the Furniture items, Steel and Wooden furniture, Steel cots, Hostel Furniture, Court Hall Furniture etc., with TANSI only as stipulated in the Tender Transparency Act as above; adhering to their payment terms etc. Only if TANSI for any reason; gives up the proposal in writing regarding the inability of compliance of the procurement, the Executive Engineers should opt for other sources of procurement.
