The Comptroller & Auditor General of India has issued orders for reimbursement of expenditure on newspaper on half yearly basis to different level officers working in IA&AD.

As per the above order, Senior Accounts Officers/Accounts Officers/Assistant Accounts Officers of IA&AD are entitled to the reimbursement of @ Rs. 500/- Per Month w.e.f. 01April 2018 on production of certificate (Annexure A) enclosed for the expenditure incurred.

It is therefore requested to admit claims submitted by Senior Divisional Accounts Officers/ Divisional Accounts Officers (Gr. I) towards reimbursement of expenditure on News paper and make payment subject to sanction of necessary funds from the Govt. of Tamilnadu.
