Sub: Water Resources Department – Issuance of guidelines for granting Permission to Use / No Objection Certificate for the Development Projects in Water Bodies/ Water Course Poramboke Lands based on the orders of Hon'ble Madurai Bench of Madras High Court – Collection of application fee and technical guidance fees – Remittance head of accounts communicated - reg.

Ref: Government Order (Ms) No.101/Water Resources (R2) Department/Dated:30.09.2024.

In the Government Order cited above, the Government have issued guidelines for granting Permission to Use / No Objection Certificate for the development projects in water bodies / water course poramboke lands based on the orders of Hon'ble Madurai Bench of Madras High Court.

In serial no.3 of the guidelines annexed with the above Government Order, it is insisted that the application along with documents for seeking NOC shall be

accompanied by the fee (non-refundable) of Rs.5,000/- inclusive of Goods and Service Tax (GST) and as may be revised by the Government from time to time and in serial no.13 of the above insisted to pay Technical guidance fee (non-refundable) of Rs.25,000/- inclusive of Goods and Service Tax (GST) and as may be revised by the Government from time to time for rendering technical support from Water Resources Department shall be paid by the Project Proponent along with application.

In this regard, it is informed that the above mentioned application fee and technical guidance fee have to be remitted to the following head of accounts:-

Application Fees :-

Technical Guidance Fees:-

“0701-Major and Medium Irrigation – 80 General –

The Regional and Functional Chief Engineers are requested to instruct their subordinates to remit application fees and technical guidance fees for the NOC to the above mentioned head of accounts without any deviation.
